LEGION UPDATE

NOTE FROM OUR NATIONAL COMMANDER

Now that the holiday season is upon us, we are surrounded by distraction – the endless shopping list, the tempting sales in stores and the many parties to attend. Sometimes, this distraction can cause us to forget that there are still 60,000 U.S. troops deployed overseas. We must remember to honor these men and women who fight for our freedom while we enjoy the holidays in the comfort of our home, with our family and friends.

Remembrance can be shown by sending care packages or by providing the deployed servicemember with a piece of home, which the Illinois Legion Family has fulfilled for the past seven years in partnership with Operation: Military Kids by giving Illinois deployed servicemembers and their families with family photo pillow cases. The pillow case project is conducted during deployment ceremonies that Illinois Legion Family members attend in effort to take photos of each servicemember and his or her family, print the photo out on special transfer sheets, iron it onto pillow cases, and present one photo pillow case to each person in the family. The servicemember takes his or hers overseas, and each family member gets one of their own to keep at home and enjoy the comfort of a "hug" from their deployed loved one.

For the holidays this year, Illinois Legion Family members pro-

vided more than 200 Illinois Army National
Guard men and women deploying to Afghanistan with pillow cases to take with them. The pillow cases are free of charge to the servicemember and the family as a way of saying, "Thank you for all you do!" said Cheri Stanton, a member of Post 136 in Monmouth, Ill. "It's such a rewarding program, and we do it to show them that we still care. That we are all veterans wanting to help out."

Since 2006, more than 16,000 pillow cases have been made for Illinois deployed servicemembers.

I'm proud of our Legion Family members for this simple act of generosity, which shows our servicemembers and their families that they are remembered, especially during the holidays. As you

gather with your loved ones this month, remember the deployed troops and their families by reaching out to them and showing your support. Show them that you still care.





SENATE BILL WOULD EXPAND VA ELIGIBILITY



In its written testimony submitted Oct. 30 to the Senate Committee on Veterans' Affairs, The American Legion expressed support for draft legislation sponsored by Sen. Bernie Sanders, I-Vt., that would "expand and enhance eligibility for health care and ser-

vices through the Department of Veterans Affairs."

Sanders' bill would take into account the varying income levels among counties in any given state, and also establish new statewide income thresholds, in determining veterans' eligibility for VA health care.

The bill further stipulates that all required modifications for implementation of the new income criteria must be completed within five years of enactment.

Currently, VA applies a nationwide Geographic Means Test (GMT) to a veteran's personal income, regardless of where

he or she lives. If the income level is at or below the GMT, veterans are eligible for Priority Group 7 status; if the income is higher, they are assigned to the Priority 8 Group.

If they agree to pay the applicable co-payments, Group 7 veterans may enroll in VA health care. Group 8 veterans with non-service connected conditions whose incomes are higher than the GMT are not eligible for VA enrollment.

The American Legion supports the aim of Sanders' bill, and is also urging Congress to enact legislation that would direct VA to automatically enroll eligible veterans into its healthcare system as soon as they leave active duty in the military – supported by Resolution 75, passed at the Legion's 95th annual convention in Houston last August.

Other Legion-backed bills pending in the Senate include:

• Rural Veterans Mental Health Care Improvement Acts (S.1155 and S.1411)

VETERANS SERVICE CORNER

SHOULD I APPEAL THE VA'S DECISION ON MY CLAIM?

I encourage claimants to appeal an unfavorable decision if their representing service officer identifies information that VA missed that could result in a definite grant of benefits. However, there are cases where there is no legal basis for either appeal or reopening of the claim.

An initial appeal is referred to as a Notice of Disagreement (NOD), and it is imperative that you have accredited representation when filing a NOD. If you file a NOD without a representative, you may not be able to gain representation once the appeal process has begun, resulting in you being responsible for self-representation in the hearing.

When filing the appeal form, the claimant must tell VA that they disagree with the decision, and they must state if the disagreement is regarding one contention or multiple contentions listed on the same written decision. The claimant must also provide a reason for disagreement and cite evidence which supports their position.

The NOD must take place within one year from receipt of rating decision. At this point, the claimant becomes the

appellate. The appellate is encouraged to utilize VA Form 21 -0958 or VA Form 21-4138 as a secondary option. A NOD does not have to be packaged in either one of these forms in order to be accepted by the VA regional office (VARO). The NOD could be written on paper as long as it fulfills the requirement of informing the VA of disagreement and what is disagreed upon.

After proper receipt of the NOD, VARO will send correspondence to the appellate to determine if he or she desires a hearing, or a De Novo Review, taking into account all evidence while giving no consideration to the previous decision.

The upside to a NOD is that it preserves the effective date of a claim, meaning if a grant of benefits is achieved on appeal the appellate will be paid retroactively back to the date the claim was originally filed.

NEW RETROACTIVE BENEFIT

WASHINGTON – The Department of Veterans Affairs announced today that Veterans filing an original Fully Developed Claim (FDC) for service-connected disability compensation may be entitled to up to one-year of retroactive disability benefits. The retroactive benefits, which are in effect August 6, 2013, through August 5, 2015, are a result of a comprehensive legislative package passed by Congress and signed into law by President Obama last year.

"VA strongly encourages Veterans to work with Veterans Service Organizations to file Fully Developed Claims and participate in this initiative, since it means more money in eligible Veterans' pockets simply by providing VA the information it needs up front," said Allison A. Hickey, Under Secretary for Benefits. "At the same time, it helps reduce the inventory of pending claims by speeding the process."

Filing an FDC is typically the fastest way for Veterans to receive a decision on their claims because Fully Developed Claims require Veterans to provide all supporting evidence in their possession when they submit their claims. Often, this is evidence that VA legally must attempt to collect on

the Veteran's behalf, which is already in the Veteran's possession, or is evidence the Veteran could easily obtain, like private treatment records.

When Veterans submit such evidence with their claims, it significantly reduces the amount of time VA spends gathering evidence from them or other sources -- often the longest part of the claims process. While VA will still make efforts to obtain federal records on the Veterans' behalf, the submittal of non-federal records (and any federal records the Veteran may have) with the claim allows VA to issue a decision to the Veteran more quickly. Typically, VA processes FDCs in half the time it takes for a traditionally filed claim.

FDCs can be filed digitally through the joint, DoD-VA online portal, eBenefits. VA encourages Veterans who cannot file online to work with an accredited Veterans Service Organization (VSO) who can file claims digitally on Veterans' behalf. While submitting an FDC provides a faster decision for any compensation or pension claim, only

Veterans who are submitting their very first compensation claim as an FDC are potentially eligible for up to one-year of retroactive disability benefits under the newly implemented law.

FDCs help eliminate VA's claims backlog because they increase production of claims decisions and decrease waiting times. Also, VA assigns FDCs a higher priority than other claims which means Veterans receive decisions to their claim faster than traditional claims.

VA continues to prioritize other specific categories of claims, including those of seriously wounded, terminally ill, Medal of Honor recipients, former Prisoners of War, the homeless and those experiencing extreme financial hardship. As part of its drive to eliminate the claims backlog in 2015, VA also gives a priority to claims more than a year old.

In May, VA announced a new partnership with Veterans Service Organizations and others known as the "Community of Practice," an effort that seeks to reduce the compensation

claims backlog for Veterans by increasing the number of FDCs filed by Veterans and their advocates.

VA is continuing to implement several initiatives to meet the Department's goal to eliminate the claims backlog in 2015. In May, VA announced that it was mandating overtime for claims processors in its 56 regional benefits offices to increase production of compensation claims decisions through the end of FY 2013. In April, VA launched an initiative to expedite disability compensation claims decisions for Veterans who have a waited a year or longer.

As a result of these initiatives, VA's total claims inventory remains at lower levels not seen since August 2011. The number of claims in the VA backlog – claims pending over 125 days – has been reduced by 17 percent compared to the highest point in March 2013.

Veterans can learn more about disability benefits on the joint Department of Defense—VA web portal eBenefits, and the FDC program.

- Improving Job Opportunities for Veterans Act (S.1216)
- SCRA Enhancement and Improvement Act (bill number TBD)
- A bill that would require VA to inform veterans who file benefits claims electronically that "relevant services may be available from veterans service organizations" (S.1295)
- Servicemembers Electronic Health Records Act (S.1295)
- Mental Health Support for Veterans Families and Caregivers Act (bill number TBD)
