NEW BUSINESS AND CORRESPONDANCES:

• 2nd Vice Cdr. Scott Edgell presented the current situation with our sewage line and the repairs required to allow proper use of our building facilities. The Legionnaire officers solicited three certified plumbers for cost and suggestions. Vice Cdr. Scott Edgell discussed the decision the executive board voted on to use Koser Excavating, Manheim to install the new pipe to resolve the sections of pipe that have deteriorated. He will allow us to finance the project cost @1.5% month. His project cost is \$15,500, with an NTE of \$18,500. This includes the cold patching of the driveway and road. This work can be done in 2 days, he will be doing the work in March. We will need to get future estimates to do final drive and road patch.

Motion to accept the Koser Excavating proposal by Comrade Jim Vollrath, Historian Reed Boring second. Discussion about all options. Approved.

- Comrade Jim Vollrath discussed that state and national need to be added to our rider. This is already in the works.
- Question regarding guests being able to play games of change tickets, they are allowed. This has been confirmed with the LCB.
- Historian Reed Boring reported on the donation solicitation presented in previous meeting. The
 request was for a Hempfield student a \$50.00 relief donation for a school trip. Motion to
 approve the \$100.00 donation by Member at Large Mike Gamber, seconded by Chaplain Ron
 Baldwin. Approved.
- Comrade Jim Vollrath reminded us about the State Commanders dinner and that we should place an ad for the April Dinner.
- Second Vice Cdr. Discussed the need for volunteers to head fund raising initiatives.
